APPLICATION FOR MBA PROGRAMME



1.0 Eligibility to Apply

Graduates in any discipline recognized by the Association of Indian Universities (AIU), with a minimum of 15 years of education (10+2+3 or 10+2+4 basis) and minimum 50% aggregate marks (or equivalent CGPA) can apply. The percentage of aggregate marks is to be calculated taking all subjects into consideration including optional subjects.

Where the University/Institution does not have any scheme for converting CGPA into equivalent marks, percentage score would be calculated by dividing the obtained CGPA with the maximum possible CGPA and multiplying the result with 100.

Those who are in the final year bachelor's degree course and expect to complete all the requirements of graduation before 30th June, 2026 can also apply.



2.0 Programme Fee

The total MBA Course Fee of ₹18,00,620/- (Rupees eighteen lakh six hundred twenty) is payable as per the details given below. The fee includes Admission & Administration Fee, Tuition Fee, Development Fee, Extra Curricular Activities Fee, AC Hostel Fee, Mess Fee, Laundry Fee, Books & Materials and Laptop etc.

5.0 Instructions for Filling-Up the Application Form

- Candidate's name, date of birth and parent's name should be exactly the same as mentioned in the 10th certificate.
- Options filled by the candidate can't be changed at a later stage.
- Email ID, phone number & address submitted at the time of registration will be used for all correspondences until admission process is completed. Change in Email ID, phone number & address will NOT be permitted under any circumstances.
- Candidates may retain the downloaded copy of filled in application form for future correspondence, if required.



6.0 KIITEE Management 2026

6.1 Procedure

- The entrance examination will be an "Objective-type" computer-based test where the questions would be shown and answers would be marked using a desktop computer.
- Candidates need to be conversant with the basics of computer application, such as using the mouse, keyboard and other basic computing tasks.
- More detailed instructions along with the mock test link would be made available before the test at the KSOM website, www.ksom.ac.in.

6.2 Question Section Overview

The entrance examination will be of two and half hours duration. There will be a total of 120 multiple choice questions. Specific details on number of questions for each subject/section are enumerated below.

6.3 Evaluation Criteria

- Language of the questions will be in English. The questions will not be in any other language.
- All the questions will be of objective type with four marks (+4) for each correct response, minus one mark (-1) for each incorrect response & zero (0) for no response.



6.4 Rules and Regulations

- Candidates have to bring their printed admit cards to the examination hall and reach the hall at least 30 minutes before the commencement of the examination so as to listen to all the rules/guidelines of taking the examination.
- No candidate, under any circumstances, will be allowed to enter the examination centre after the commencement of the examination.
- A seat indicating index number / application number will be allocated to each candidate. Candidates should find out and occupy their allotted seats only. The candidature of a candidate, found to have changed hall or seat on his/her own, shall be cancelled and no plea would be accepted.
- No candidate, without the permission of the Centre Superintendent / Invigilator, can leave his/her seat or examination hall till the completion of the examination.
- Smoking in the examination hall is strictly prohibited. Tea, coffee, cold drinks, snacks, etc. are not allowed inside the examination hall.
- Phones, pagers, cameras or any other such electronic, electro-mechanical or electrical devices are not allowed inside the examination hall.
- The invigilator will announce the commencement and completion of the examination. Candidates should leave their seats on hearing the announcement of completion.
- If a candidate is found using unfair means or impersonating, his/her candidature shall be cancelled and he/she will be debarred from the examination.

6.5 Non-Attendance

For those who are unable to appear the entrance examination on the scheduled dates for any reason, no re-examination shall be held for them under any circumstances.



7.0 Entrance Test

- All eligible candidates would be called for the computer based online KIITEE Management entrance examination to be conducted in the designated test centres across India, as per the scheduled dates mentioned earlier. The number of entrance test days for each city will vary and it will be mentioned in the admit card.
- The test centres are mentioned in the booklet/ application form. For any unforeseeable reason if the test could not be conducted at any selected centre, then the candidate will be asked to appear for the test in his/her nearest available centre.



8.0 Admit Card

- Candidates can download the admit card from the KSOM website - www.ksom.ac.in.
- Candidates must not mutilate the admit card nor make any changes therein.
- Candidates must preserve the admit card till the admission process is over.
- Candidates facing any difficulty may contact the admission office through email - admission@ksom.ac.in.





9.0 Result

- Result of the KIITEE Management entrance examination will be available at the KSOM website, www.ksom.ac.in.
- On the basis of the KIITEE Management merit list, candidates will be called for Group Discussion & Personal Interview (GD & PI) and Writing Ability Test (WAT).
- Candidates will have to meet their own travel expenses for appearing for the GD & PI.
- Candidates must preserve the original result card till the admission process is over.
- GD & PI will be held at Bhubaneswar, Kolkata, Delhi, Bangalore, Jamshedpur and Mumbai. For any unforeseeable reason if the GD & PI could not be conducted at any selected centre, then the candidate will be asked to appear for the GD & PI at the centre allotted by the institute.



10.0 Submission of Documents for GD & PI

Following documents are required to be submitted by the candidates at the time of GD & PI:

- High school certificate and mark sheet
- +2 certificate and mark sheet
- Graduation certificate and all semester mark sheets
- Entrance score card
- Recent passport photograph

Any changes in the list would be communicated to the candidate in due course of time.



11.0 Final Selection & Admission Offer

The final selection will be made on the basis of the candidate's performance in the Group Discussion & Personal Interview (GD & PI), Writing Ability Test (WAT), career marks, and entrance score. Successful candidates will be intimated of their final selection through admission offer letter containing the terms and conditions of the admission. For the offer to be valid, the selected candidates, after going through contents of the admission offer letter, need to confirm and accept the offer with the terms and conditions for taking admission to the programme through "Acceptance Letter" and other documents. All the candidates who have been offered admission have to pay the fees as stipulated in the admission offer letter. Otherwise they would forfeit their seat.



12.0 Cancellation of Admission

Admission is liable to be cancelled at any point of time, either before or after admission, if:

- Any information provided in the application form/admission form is found to be incorrect or misleading.
- The candidate fails to submit the final degree result on time as stipulated or fails to secure minimum eligible marks in the degree examination.
- The terms and conditions of the admission offer letter are not fulfilled.



13.0 Legal Jurisdiction

All disputes pertaining to the conduct of KIITEE Management 2026 test for admission into MBA shall fall within the jurisdiction of Bhubaneswar, Odisha only.

If any person or officer engages himself / herself in act(s) that would result in the leakage of the question paper(s) or attempt to use any unfair means in this examination, he / she shall be liable for prosecution under the Indian Penal Code.
